Contributions to Friends of James St. George are not tax deductible for federal income tax purposes. Contributions are subject to the limitations and prohibitions offered by law. An individual may contribute a maximum of \$2,800 per election (\$5,600 combined for primary and general), and couples may contribute a maximum of \$5,600 per election (\$11,200 combined for primary and general). Joint contributions require the signature of both spouses. Federal multi-candidate PACs may contribute a maximum of \$5,000 per election (\$10,000 combined for primary and general). Contributions from corporations, labor unions, federal government contractors and foreign nationals are prohibited. Contributions must be made from personal funds, may not be made in the name of another, and may not be reimbursed by any other person. Federal law requires us to use best efforts to obtain and report the name, address, occupation and employer for each individual whose contributions aggregate in excess of \$200 in an election cycle.
